Copyright and Intellectual Property Rights remain with the artist even after you buy the original work. Purchase of Art Work from 'ECSA Ltd' does not grant you any right other than that of ownership of the product, including reproduction of work and intellectual properties

Reservation of Art Work

'ECSA Ltd' will reserve a work on receipt of online enquiry from the buyer stating: a) the details of the work being the name of the artist, title, date and medium as shown on the <u>ebenezergallery.co.uk</u> website

- b) the name and address of the buyer
- c) the name and address of the consignee
- d) the delivery address
- e) the method of payment
- f) further details as deemed necessary by the buyer

g) ECSA Ltd will confirm the reservation of the work subject to availability from which time the work will be reserved for 7 days.

1. Definitions

1.1. "Buyer" means the individual who agrees to buy the Goods from the Seller;

1.2. "Contract" means the contract between the Seller and the Buyer for the sale and purchase of Goods incorporating these Terms and Conditions;

1.3. "Art Work" means the articles that the Buyer agrees to buy from the Seller;

1.4. "Seller" means 'East Cornwall Society of Artists' (ECSA Ltd), Ebenezer Gallery, Polperro, Cornwall PL13 2RQ that owns and operates <u>ebenezergallery.co.uk</u>

2. Conditions

2.1. Nothing in these Terms and Conditions shall affect the Buyer's statutory rights as a Consumer.

2.2. These Terms and Conditions shall apply to all contracts for the sale of Art Work by the 'ECSA Ltd' to the Buyer

2.3. Acceptance of delivery of the Goods shall be deemed conclusive evidence of the Buyer's acceptance of these Terms and Conditions.

2.4. Any variation to these Terms and Conditions shall be inapplicable unless agreed in writing by the 'ECSA Ltd'.

3. Price and Payment

3.1. The price of the Goods shall be that stipulated on the Website inclusive of Post/Packing and delivery charges.

3.2. The total purchase price, inclusive of Post/Packing and delivery charges, will be displayed in the Buyer's shopping cart prior to confirming the order.

3.3. Delivery to addresses outside of United Kingdom including Channel Islands will necessitate an enquiry to ECSA Ltd to agree any additional postage costs.

3.4. After the order is received the ECSA Ltd shall confirm by email the details, description and price for the Art Work together with information on the right to cancel

3.5. Payment must be made in full before dispatch of the Art Work

3.6. Payment has not been made until we have received cleared funds representing the full amount.

3.7. If you fail to pay the purchase price in full within 7 day reservation period the Art Work will be subject to availability

4. Authenticity Of Works4.1. All works of Art arrive with the confirmation of Authenticity'An original work of Art by (artist name) purchased on ECSA Ltd'

5. Delivery

5.1. ECSA Ltd will arrange shipment of the Art Work to be dispatched by the Artist where possible within 14 days of payment clearance at which time you will be given an estimated date of arrival at the given consignee address where possible.

5.2. The Artist is responsible for the delivery of the work

5.3. Goods supplied outside the UK will normally be delivered within 28 working days of acceptance of order where possible

5.4. Goods delivered outside the UK, it shall be the buyers responsibility to ensure raise any customs documentation and ensure duty or taxes are paid.

Delivered at Place (DAP): The buyer is the importer of record and is responsible for paying any applicable custom duties and import taxes. All taxes incurred when importing to the country of destination must be paid by the buyer or the recipient.

5.5. 'ECSA Ltd' shall not be liable for any losses, costs, damages or expenses incurred by the Buyer or any third party arising directly or indirectly out of any failure to meet any estimated delivery date.

5.6. Delivery of Art Work shall be made to the Buyer's specified address who will make all arrangements necessary to take delivery of the Art Work when tendered for delivery.

5.7. Responsibility of the Art Work shall pass to the Buyer upon delivery, or where the Buyer fails to take delivery at the agreed time, or when delivery was attempted.

5.8. Ownership of Art Work shall not pass to the Buyer until payment has been made in full.

6. Return and Refund Policy

6.1. If the details and image of the work as shown on the <u>ebenezergallery.co.uk</u> website do not meet with the work received we will accept its return provided that it is in the condition it was dispatched.(see) In such circumstances ECSA Ltd must be notified within 7 days of your receipt; a full refund including return postage will be

made providing on return and examination the work is to our satisfaction in the condition it was dispatched.

6.2. Damaged work of art:

The Buyer shall inspect the Goods immediately upon receipt and shall notify the ECSA Ltd by email to ebenezergallery@gmail.com within 7 days if the Goods are damaged or do not comply with the Contract. If the Buyer fails to do so the Buyer shall be deemed to have accepted the Goods.

6.3. You have a cooling off period of 7 days after the date on which you have received the Art Work to cancel the Contract, and return the Art Work at your cost The Buyer will receive a refund of all monies paid for the Goods except for return postal charges.

Goods must be returned by the Buyer within 28 days of cancellation in the original packaging.

7. Limit Of Liability

7.1. The maximum liability for any loss arising due to our negligence will be limited to a sum equal to the value of the payment received for the work.

8. Force Majeure

8.1. The ECSA Ltd and the Artist shall not be liable for any delay or failure to perform any of its obligations if the delay or failure results from events or circumstances outside its reasonable control

9. Law And Jurisdiction

9.1. These terms and conditions are to be construed and take effect in accordance with English law.
